### WHITE CREEK TOWN BOARD MINUTES

## AUGUST 11, 2015

The White Creek Town Board held their regular monthly meeting on Tuesday, August 11, 2015 at the White Creek Town Hall. Supervisor Robert Shay called the meeting to order at 7:30 pm. Roll call was taken by the Clerk. The full Board was in attendance which consists of Supervisor Shay, Town Council Members Erin Sheridan, Barbra Kingsley, James Perry and Joe Bates. Also attending the meeting were Cambridge Central School Superintendent Vince Canini, Planning Board Chairman Neil Gifford, Highway Superintendent Chris Rieben, Town Assessor Ronna Meerwarth and Budget Officer Laura Manning.

Barbra Kingsley made the motion to approve as presented the minutes of the July 14, 2015 regular meeting and the Special Board Meeting on July 23, 2015. Joe Bates seconded the motion and all voted in favor of approval.

#### **Old Business**

# Resolution 16-2015-Increase in wattage of street lamp on Routes 22 & 68

The Board voted unanimously to change the 250 watt bulb to a 400 watt bulb at the light at the intersection of Routes 22 and 68 if there is not wattage in between the 250 and 400 watts

#### **New Business**

Cambridge Central School Superintendent Vince Canini provided a detailed explanation of how the property equalization rates are computed. A packet showing the recent rates for the Town's in the CCSD was distributed.

## **Planning Board**

Chairman Neil Gifford stated that the Board met on August 5<sup>th</sup> for their regular monthly meeting but did not have a quorum. John Carnett from

Bounce Linx was present at the meeting to present a sketch plan for a proposed cell tower on Bodenstab Lane. The action was not classified due to the lack of a quorum. Mr. Carnett will return to the Planning Board for the September 02, 2015 meeting. The proposal will be reviewed at that time.

#### **Highway Superintendent's Report**

Highway Superintendent Chris Rieben submitted his monthly report to the Board. The crew has been hauling sand, pothole patching, mowing and chip sealing.

#### **Resolution 17-2015- Electrical Bid Awarded to Ronald Buia**

The Board unanimously voted to hire Ronald Buia, Engineering P.C. to provide electrical engineering and design services for the electrical upgrade at the Town Highway Garage at the cost of seven thousand, eight hundred dollars (\$7,800.00)

#### Resolution 18-2015- Asbestos Survey and Bulk Sampling by Adirondack Environmental Services

The Town Board voted to hire Adirondack Environmental Services to perform asbestos testing and sampling at the Highway Garage at the cost of one thousand, two hundred fifteen dollars and sixty cents (\$1215.60).
