WHITE CREEK TOWN BOARD MINUTES NOVEMBER 10, 2015

The White Creek Town Board held their regular monthly meeting on Tuesday, November 10, 2015 at the Town Hall. Supervisor Shay called the meeting to order at 7:30 pm. Roll call was taken by the Clerk. After a review of the bids, Barbra Kingsley made a motion to accept the bid from Doug's Oil, Inc. at a cost of \$1.551 per gallon with \$.19 over cost. Motion to accept was seconded by James Perry and all others voted in favor.

The regular monthly meeting of the Planning Board was held on November 4th. There is one project being reviewed by the Board. A Public Hearing will be held on December 2nd for the application for a minor subdivision submitted by Bill Badgley and Christa Caron.

HIGHWAY REPORT

Highway Superintendent Chris Rieben reported that work has been done on the dump trucks. The mower repairs have been completed. Some grading, ditching and culvert replacement have been done. The Town of Arlington contacted Chris about plowing the Arlington side of Black Hole Hollow Road. Chris has shown Bob the road and has also spoken to Joe about it. The insurance company stated the Town would be covered. It looks like the two towns just have to come up with a formal agreement.
