The White Creek Town Board held their regular monthly meeting on Tuesday, February 14, 2017 at the White Creek Town Hall. Supervisor Shay called the meeting to order at 7:30 pm. #### **Planning Board Report**

#### **Appointment of Planning Board Chairman for 2017**

The Town Board made the appointment of Neil Gifford as the Chairman of the White Creek Planning Board for 2017. Motion was made by Lance Wang, seconded by Barbra Kingsley and all other voted in favor of the appointment

#### **Assessor's Report**

Assessor Ronna Meerwarth submitted her monthly report to the Board.

#### **Town Clerk's Report**

Town Clerk Lisa Austin-Cuddihy submitted her monthly report for January 2017 to the Board. The Town received \$317.45 in revenue. Lisa also reported that she had collected \$1,883,201.18 in taxes and has paid the Supervisor the \$925,613.00 for the 2017 budget.

#### **Highway Superintendent's Report**

Superintendent Chris Rieben reported that the new pickup truck has been delivered and is in service. The equipment is holding up good but they did have to replace the overflow tank on the 2009 truck. The crew has plowed a total of thirteen days since last month's meeting. Auction International has received bids on the pickup, plow and the backhoe. The bid for the backhoe was \$8,900.00 and bid for pickup was \$13,300.00 and plow for \$2,225.00. The Board members agreed with Chris' recommendation to counter offer the backhoe for \$9500.00 and counter offer for the pickup and plow together at a price of \$17,500.00. Chris stated he will contact Auctions International in the morning.

## **Budget Officer's Report**

Budget Officer Laura Manning submitted the monthly operating statement to the Board. Laura stated that the testing of the former landfill has been reduced to two times per year therefore also reducing the cost.

# **Health Officer's Report**

Supervisor Shay reported several visits and calls to various homes by Code Enforcement this past month.
