WHITE CREEK TOWN BOARD MINUTES SPECIAL MEETING MAY 22, 2018

The White Creek Town Board held a Special Meeting on Tuesday, May 22, 2018 at the White Creek Highway Garage due to the Board of Assessment Grievance Day taking place at the Town Hall. Supervisor Robert Shay called the meeting to order at 7:00 pm. Members present at the meeting were Supervisor Shay, Lance Wang, Barbra Kingsley, Tammy Taber and Heath Murphy. Highway Superintendent Chris Rieben was also present at the meeting.

Resolution 30-2018-Approval of Minutes of the May 08, 2018 Meeting Lance Wang made a motion to accept the minutes of the May 08, 2018 regular monthly meeting as presented. Barbra Kingsley seconded the motion and all voted in favor of approval.

Initially, Supervisor Shay had two items on the agenda under new business. These items were a request for evaluation for speed reduction on Niles Road and posting of weight limit signs on Niles Road. Supervisor Shay announced that he was withdrawing both items from the agenda for this evening. He proposed that these items be revisited at the July 10, 2018 meeting.

Resolution 31-2018 - Accept bid on loader from Auctions International

Highway Superintendent Chris Rieben provided the Board members with the bid history for the 2005 Komatsu Front Wheel Loader. The bidding closed out with the highest bid of \$52,500.00. This figure is \$2,500.00 over the trade in price of \$50,000.00 offered by John Deere. Lance Wang made the motion to accept the bid of \$52,500.00 from Auctions International. Heath Murphy seconded the motion and all others voted in favor of accepting the bid.

There being no further business on the agenda, the floor was opened for town residents comments. There were several comments from individuals voicing their opinions about the truck traffic issue, speed limits, weight limits and health and safety issues in the Niles Road and Meetinghouse Road area. The Board assured the residents in attendance that their intent is not to put anyone out of business or affect any businesses in a negative way. The Board talked about requesting an evaluation from NYSDOT in order to reduce the speed limit on Niles Road and

Meetinghouse Road. Barbra Kingsley made a motion to request a lower speed limit on Niles Road; the motion did not receive a second, motion failed. As the meeting was winding down, it was agreed that Highway Superintendent Chris Rieben will check on what can be done at the intersection of Niles Road and Meetinghouse Road to improve the visibility there. Also the Highway Committee will meet and come back to the June meeting with some recommendations for trying to solve some of the issues in this area of the town.

Lance Wang made a motion to adjourn the meeting at 7:56 pm. Motion was seconded by Barbra Kinsley and all others voted in favor. Meeting was adjourned at 7:57 pm.
