

WHITE CREEK TOWN BOARD MINUTES
MAY 11, 2021

The White Creek Town Board held their regular monthly meeting on Tuesday, May 11, 2021 at the White Creek Town Hall. Supervisor Griffith called the meeting to order at 7pm. Roll call was taken by the Clerk. Supervisor James Griffith was present along with Town Board Members Heath Murphy, Barbra Kingsley, Tammy Taber and Lance Wang. Also present at the meeting were Highway Superintendent Chris Rieben, Planning Board Chairman Ron McEvelly and Budget Officer Laura Manning.

Resolution 22-2021 – Adoption of April 13, 2021 Town Board Minutes and April 21, 2021 Special Meeting Minutes

Lance Wang made a motion to waive the reading of the April 13, 2021 Town Board Meeting Minutes and the April 21, 2021 Special Meeting Minutes and approved them as presented. Barbra Kingsley seconded the motion and all present voted in favor of their adoption.

Town Residents Comments

Town residents Ralph Provenza and Nancy Moses Alexander introduced themselves and stated they were attending the meeting as both are running for the Town Board seats (2) in the upcoming November election.

Planning Board Report

Planning Board Chairman Ron McEvelly stated that the May 5th Planning Board meeting consisted of an approval of a Residential Site Plan Application submitted by Desiree LeRay for a mobile home on Hunt Lane and there are four (4) Boundary Line Adjustments applications pending approval.

Town Clerk's Report

Town Clerk Lisa Austin-Cuddihy submitted her monthly report for April 2021. Total revenues for the month were \$1,037.00 with \$419.93 being the Town's portion.

Budget Officer's Report

Budget Officer Laura Manning presented the monthly operating statement to the Board. Laura stated that since the court has opened back up there has been an increase in revenues. All other expenditures are on target with the budget.

Highway Superintendent's Report

Highway Superintendent submitted a monthly report of activities to the Board. They have been grading, ditching and cutting brush. The CHIPS payment from the money that was withheld last year has not yet been received. Chris stated that we should be receiving around \$249,000 for this year. The pickup truck went back on Auctions International and brought a bid of \$28,200.00.

Resolution 23-2021 – Reject Bid

The Board members voted to reject the bid of \$28,200.00 and make a counter offer of \$30,000.00 to the bidder through Auctions International. Barbra Kingsley made the motion, seconded by Supervisor Griffith and all others voted in favor. Chris will contact Marc from Auctions International and present the counter bid.

Audit Report – Resolution 24-2021 – Approval of payment of vouchers

Heath Murphy made a motion to approve the payment of vouchers submitted in the amount of \$13,266.38. Lance Wang seconded the motion and all others voted in favor of approval.

Justice Court Report

Judge Scott Lucey submitted the monthly report for April 2021 in the amount of \$6,301.00.

Supervisor's Report

Supervisor Griffith stated that he has been in contact with Code Enforcement Office Theo Celani and he will be checking on the complaints received in the hamlet. Supervisor Griffith also mentioned that the Board of Supervisors will be reviewing the 188 pages of guidance for Covid Relief Funds in the near future.

Adjourn

There being no further business on the agenda, Supervisor Griffith moved to adjourn the meeting. Lance Wang seconded the motion and all were in favor. Meeting adjourned at 7:25pm.
