

WHITE CREEK TOWN BOARD MINUTES JULY 13, 2021

The White Creek Town Board held their regular monthly meeting on Tuesday, July 13, 2021 at the Town Hall. Members present were Supervisor James Griffith, Lance Wang, Heath Murphy and Barbra Kingsley. Tammy Taber was absent. Supervisor Griffith called the meeting to order at 7pm.

Resolution 27-2021 – Approval of June 8, 2021 Board Minutes

Lance Wang made a motion to approve the minutes of the June 8, 2021 Town Board meeting as presented. Barbra Kingsley seconded the motion and all voted in favor of approval.

Opening of Bids for the 2017 Chevy Pickup

After three weeks of advertising the bid, one bid was received on the pickup. The bid was received from Thomas Dooley, Sr. in the amount of twenty-one thousand, eight hundred eighty dollars (\$21,880.00). Barbra Kingsley made a motion to reject the bid. Motion was seconded by Lance Wang and all voted in favor of rejecting the bid from Mr. Dooley.

Assessor's Report

Town Assessor Ronna Meerwarth submitted a monthly report to the Board. The office had not received the transfers for the month. The Board of Review will have their second meeting on July 31st. The purpose is to remove exemptions and rule on two property owners who were postponed in order to collect more information to make their decision. Ronna and Carol met with a representative from GAR, the company doing the town wide reassessment. Data mailers will be sent out to property owners sometime in August or September.

Town Clerk's Report

Town Clerk Lisa Austin-Cuddihy submitted a monthly report for June. Total revenues were \$608.00 with the town's portion being \$305.22.

Budget Officer's Report

Budget Officer Laura Manning submitted the monthly Operating Statement to the Board.

Highway Superintendent's Report

Superintendent Chris Rieben submitted a monthly report of activities to the Board. The paving is finished on Meeting House and Niles Roads. The County DPW helped put an apron on Rice Lane. This will allow the grader not to be right in County Route 68 while grading the road. They put shoulders on Meeting House and Niles Road and are still mowing. Rear tires were put on the tractor.

Audit Report – Resolution 28-2021 – Approval of Vouchers

Heath Murphy made a motion to approve vouchers submitted in the amount of \$291,661.96. Lance Wang seconded the motion and all others voted in favor of approval.

Justice Court Report

Judge Scott Lucey submitted the monthly report. The Court collected \$2,826.00 in fines for the month of June.

With no further business on the agenda, Lance Wang made a motion to adjourn the meeting. Barbra Kingsley seconded the motion and all others voted in favor. Meeting adjourned at 7:20 pm.
